Dear RSE families,

I hope that this letter finds you well and that you are taking good care of yourself and your family. Yesterday, Governor Andrew Cuomo issued an executive order that states: “Every school in New York State is hereby directed to close no later than March 18, for a period of two weeks, ending April 1, 2020. The state will reassess at that time whether to extend such closure beyond this date and may continue to suspend the 180-day instructional requirement.”

As a result of this Executive Order, our children would return back to school on April 2nd, unless we hear otherwise in the coming days. I will be sure to communicate information with you as it becomes available.

The Governor has also charged Superintendents in Suffolk County with submitting a plan for instruction outside of school, for the days that do not constitute snow days or Spring break. As a result, our Google Classrooms will go live on **March 26th** and students should begin engaging in the materials that the teachers have created for them. At that time, if you have questions or require assistance, please feel free to reach out to your child’s teacher via email, or other means that have been established with you prior. Staff email addresses are attached to this email.

Our students in grades fifth and sixth grade were all issued a computer at the beginning of the school year, that they take home daily. For our younger learners, there are iPads in the classroom that they utilize. If your child needs to borrow the iPad to be used at home for At-HomeLearning, you may make an appointment to come into the school to retrieve the device. This can occur by contacting Mrs. Martel at martel@rsufsd.org or calling at 631-325-0203 ext 104, and scheduling a time to do so. Someone will be available between 8AM and 2PM. We will have everything ready for you when you arrive.

I will keep you apprised as things evolve. Please continue to practice social distancing and enjoy this time with your children. We sure do miss them!
